- Signups NRCS Statewide is now taking signups for EQIP, AEM through November 19th. Other Programs like GRP, WRP expired on September 30th, so we will not be doing anything with those programs until a new farm bill is passed.
- Nickerson Farm We are in the process of writing a wetland mitigation for them. We will then present that to them when it is completed.

- 3. Other Wetlands Violations We are also working on a plan for another violation on a different farm.
- 4. Local Working Group We will be having an additional meeting on November 5th, which came out of the original Local Working Group meeting that we had. This will be to try and get some Technical Service Providers (TSP) to do pest management for the grape industry in the county. We would like to have something in place by the end of the EQIP signup.

 - J-High Acres Jay has been doing the construction inspection at J-High Acers for the past month. They have the sand lane almost completed, so we can get that certified by the engineer.
 - Country Ayre Is getting ready to purchase equipment for their separator. They have received three quotes for the purchase of equipment.
 - 3. Oak View Dairy Moving along nicely, but we are very worried about the rain that is coming. I think the lagoon will be pretty much done. We would like to seed 3 sides of the lagoon soon and we will add some annual rye grass. The road crossing is done.
 - 4. **Hydro-Seeding** I plan to finish hydro-seeding on Friday for 2012 and then we will winterize it and put it away for the season.
 - 5. County Forestry Contract Dave Spann has finished the field work for the timber sale. Dave met with Tracy Franz so they can get started on the paperwork for the Law Dept.
 - 6. 2012 2% Projects Update All of the 2% projects for 2012 have been completed and submitted for payment to the county with the exception of Moon Brook, JCC Project we are still waiting for the rest of the invoices.
 - 7. **Round 18** The Plan of Work has been submitted to Albany, so now we are waiting for a contract so we can get started.

October 2012 Division of Land & Water Resources Report for Region 3

- ✓ The Round 19 RFP for the Agricultural Nonpoint Source Abatement and Control Program (Ag NPS Grants) has been announced and is due at the Department at the close of business on December 10. New for this round is a screening tool for covered structures (i.e. barnyards), and a planning tool for cover crop projects. I would be happy to try and review any draft proposals if given enough lead time. I have been told there will be a webinar on Rd 19; stay tuned.
- ✓ I am continuing to work with Districts on Rd 18 Ag NPS Plans of Work. There are 17 projects in our Region. Currently, 4 are complete, 11 are in progress, and 2 are yet to be submitted.
- ✓ Bethany Bzduch, formally of the Wyoming Co. SWCD, has settled into her new position with the Cortland Co. SWCD as a Natural Resource Conservationist. Her position is contracted to the Division of Land & Water Resources to assist me with Ag NPS Grants, AEM, and other odds and ends within our Division. She will also assist other Regions as needed. - ✓ In addition to Bethany, Ron Bush (315-436-4547; <u>ronald.bush@cortlandswcd.org</u>), formally of the Onondaga Co. SWCD, has been hired to a similar position through Cortland County to assist Cliff Frasier in Region 5. Lauren Lyons-Swift has also been hired through Cortland County to work at the Division's Albany Office to assist with the administration of Ag NPS Grants and AEM.
- ✓ Conservation Financial Assistance (Part B) request forms for 2013 were e-mailed out to you and are due to the Division office by November 1, 2012. I have been told this is a "hard" date and late requests will not be eligible for funding if it becomes available.
- ✓ As a reminder, 2012 Part B projects must be completed by the end of this year.
- ✓ The registration package for the AEM Workshop to be held November 13 and 14 in Auburn was recently e-mailed out to you. Registration forms are due back to the Division by November 2. Up to four folks from your county can attend; after your lead AEM person or Manager, you must invite NRCS and Cooperative Extension, after that it is open to additional District staff, Directors, and other partners. - ✓ Finally, in case you did not know, Phil Griswold has retired as the District Manager of the Seneca Co. SWCD after over 30 years of service. He has been replaced as Manager by Jim Malyj. Congratulations Phil and Jim.

Authorizing participation by the Chautauqua County Soil and Water Conservation District in the Agricultural Nonpoint Source Abatement and Control Program created pursuant to section 11-b of the New York State Soil and Water Conservation Districts Law.

WHEREAS, the New York State Soil and Water Conservation Committee has issued a Request for Proposals inviting Soil and Water Conservation Districts or groups of Districts acting jointly to submit proposals for funding under Round 19 of the Agricultural Nonpoint Source Abatement and Control Program; and

WHEREAS, funds are available for projects that consist of activities that will reduce, abate, control, or prevent nonpoint source pollution originating from agricultural sources; and

WHEREAS, the Chautauqua County Soil and Water Conservation District has determined that certain work, as described in its application and attachments, (the "Project") is in the public interest and consists of activities that will reduce and/or prevent nonpoint source pollution from agricultural sources;

NOW, THERFORE, BE IT RESOLVED by the Chautauqua County Soil and Water Conservation District Board

1) That **David Wilson**, **District Field Manager**, or such person's successor in office, is the representative to act on behalf of the District's governing body in all matters related to State Assistance under Round 19 of the Agricultural Nonpoint Source Abatement and Control Program. The representative is authorized to make application, execute the contract for State Assistance, submit project documentation, and otherwise act for the District governing body in all matters related to the Project;

2) That the District agrees to fund its portion of the cost of the Project as provided in the application;

3) That one (1) certified copy of this Resolution be prepared and attached to the application for funding under Round 19 of the Agricultural Nonpoint Source Abatement and Control Program;

4) That this resolution take effect immediately.
