## New York State Soil & Water Conservation Committee Region 1 Report - November 2014 Submitted by, Victor DiGiacomo – Region 1 Associate Environmental Analyst

AGNPS: I believe most of you have fulfilled the requirement but if you have not, as a reminder, interim progress reports for all open AGNPS contracts are due November 1. The report form can be filled out electronically and emailed on or before the due date to Judy Snyder: Judy.Snyder@agriculture.ny.gov. **AEM Base Year 10:** Reminder, interim reports for AEM Base Year 10 work through the Tiers is due December 5th. The AEM Base interim report serves a couple key roles: (1) a chance to take stock of work done by the halfway mark relative the AEM Annual Action Plan for Year 10 and (2) voucher for an additional payment for work done beyond any advance funds already received. Look for an email from Greg Albrecht in the near future for instructions (same approach as in past years).

**NYACD Annual Meeting**: The NYACD Annual Meeting and Administrative Conference convened October 21st to the 23rd in Utica. The meeting was well attended and the response from folks is that the training provided on District issues was very well received. There were several resolutions bought before the membership of NYACD, discussed and approved. Please contact your NYACD Division Director for more information.

Annual CCA Training: The Annual Northeast Region Certified Crop Advisor Annual Training will be held in East Syracuse at the Double Tree Inn on December 2nd through the 4th. Water Quality Improvement Project (WQIP) Program Grants Announced: On October 28, Governor Cuomo announced \$39.5 million for 134 local and regional grants for Round 11 of the DEC's WQIP Program. These projects are expected to improve water quality, reduce polluted runoff and restore waterbodies and aquatic habitats. Many SWCDs as well as regional groups of SWCDs were awarded funding for MS4 work, polluted runoff abatement and control from non-farm sources; and aquatic habitat restoration. 2014 Soil Health Mini-Grant Program: State Agriculture Commissioner Richard A. Ball announced recently an award of \$295,000 in funding that will help 13 County Soil and Water Conservation Districts in the Great Lakes and Mohawk River Watersheds develop soil health programs that will protect New York's lakes, streams and rivers from potential agricultural runoff. This assistance is awarded through the New York State Ecosystem Based Management (EBM) Program, which is funded through the Environmental Protection Fund (EPF). The Service requests interested entities to submit restoration, research and regional project proposals for the restoration of the Great Lakes fish and wildlife resources, as authorized under the Act (16 USC 941c). The deadline for proposal submissions is Monday, December 15, 2014 by 8:00 p.m. EST.
