AgNPS Program

Round 22 – The AGNPS Round 22 RFP was recently approved by the SWCC at their December 2015 meeting in Utica, NY. The State will be approving the release of the Round 22 RFP sometime after the New Year with a due date in early April 2016. The RFP will only be advertised on the Grants Gateway. The RFP and other application materials will be linked through the Department of Agriculture and Markets website and the NYS SWCC SharePoint Site. Applications will be submitted through SharePoint. If you have not already accessed SharePoint or set up your account please do so as soon as possible.

Overdue Close-outs: Some Districts began receiving letters this week about overdue close-outs on older AGNPS Grants. The SWCC and Ag and Markets are sending reminders that all AGNPS grants are required to be closed-out within 60 days of the end of contract. Most of the paperwork required for the close-out should be completed throughout the life of the contract (procurement forms, farm expenditure summaries, etc.). Having these forms filled out and signed by the landowner as each task is completed will reduce a significant amount of time during close out. Reminders are also being sent out for grants that may have upcoming end dates about the need to close-out these active grants in a timely manner. Please contact your local AEA for assistance and or to schedule a close-out.

AGNPS Tip of the Month #1: When reviewing quotes from contractors with the Landowner, take a few extra minutes to enter them into the Procurement Form. While the Landowner is still in the office, have them sign and date the appropriate section of the form.

Funding Opportunities

DEC Announces Aquatic Invasive Species Prevention Grant Program: \$2 million in grants are available to organizations for projects to prevent the spread of aquatic invasive species in New York State's waterways. The New York State Environmental Protection Fund (EPF) is providing the \$2 million for eligible projects. Grant amounts will range from a minimum of \$25,000 up to a maximum of \$100,000. A 25-percent match is required. For a full list of eligible and ineligible forms of match, please view the Request for Application (RFA) at <u>HERE</u>. The highest scoring projects will have a statewide or regional focus rather than a local focus, involve multiple partners and stakeholders.

NOAA's Great Lakes Regional Habitat Restoration Partnerships: NOAA's Restoration Center has released a federal funding opportunity (FFO) for habitat restoration in Great Lakes Areas of Concern. The FFO is available at http://www.grants.gov/, funding number NOAA-NMFS-HCPO-2016-2004742. The closing date is February 2, 2016. Through this solicitation, NOAA seeks to openly compete funding available for multi-year Great Lakes Regional Habitat Restoration Partnerships. Partnerships will result in implementation of a wide-range of individual habitat restoration projects focused in <u>U.S. Great Lakes Areas of Concern</u> with funds provided by the Great Lakes Restoration Initiative. NOAA anticipates up to \$5 million may be available to establish habitat restoration partnerships in 2016, with annual funding anticipated to maintain them for up to three years. Typical Partnership awards are expected to range from \$1,000,000 to \$5,000,000 per year. Funding will support both engineering and design projects and on the ground implementation projects.
