## **SPECIAL NOTICE: 2021 TREE & SHRUB CURBSIDE PICK-UP INSTRUCTIONS**

Dear Valued 2021 Tree & Shrub Sale Customers:

In accordance with the closing of all county offices throughout NYS due to the COVID-19 outbreak, our office is closed to the public at this time. However, we are still available by phone (716-664-2351 ext. 5) Monday through Friday from 8 AM to 4:30 PM.

In order to still hold our annual tree and shrub sale, we will be organizing a curb-side pick-up to distribute orders in an effort to minimize personal contact. **Curbside pick-up will be held on Friday, April 23<sup>rd</sup> from 12 PM to 7 PM and Saturday, April 24<sup>th</sup> from 9 AM to 3 PM at 3542 Turner Road, Jamestown, New York 14701.**

According to New York State law due to the COVID-19 pandemic, it is mandatory that you wear a mask or face covering whenever exiting your vehicle. Someone from the District will meet customers at their vehicle prior to the Tree Pick Up Point to take the name listed on the order. When it is your turn at the pick-up point marked in green on the map below, a staff member will deliver your order to your vehicle.

**To make this a positive and safe experience for all involved, it is imperative that you follow the traffic plan shown below without any exceptions and patiently wait your turn. Please stay in your vehicle at all times unless we need your assistance to load your order into your vehicle.**

Our staff will work diligently to get everyone through the traffic line as quickly as possible. We thank you for your cooperation during this difficult time and graciously thank all who have plan to place an order.



## Traveling from Out of the Area?

**Buffalo, New York:** Take I-90 West. Follow I-90 West to Exit 59 (Dunkirk/Fredonia, New York). Take NY-60 South to Jamestown, New York. Stay on NY-60 South throughout Cassadaga and Sinclairville. It will be necessary to take a right at the traffic light in Gerry, New York to continue to Jamestown, New York on NY-60. Take a **right** onto Girts Road and a quick right onto Turner Road. The Chautauqua County Soil & Water Conservation District Storage Barn will be located on your right. Please follow the traffic plan listed on page one. *If you wish to avoid the cost of tolls, take NY-5 West or US-20 instead of I-90 West to NY-60 South in Fredonia.*

**Dunkirk, New York & Fredonia, New York :** When traveling from Dunkirk, New York & Fredonia, New York: Take NY-60 South to Jamestown, New York. Stay on NY-60 South throughout Cassadaga and Sinclairville. It will be necessary to take a right at the traffic light in Gerry, New York to continue to Jamestown, New York on NY-60. Take a **right** onto Girts Road and a quick right onto Turner Road. The Chautauqua County Soil & Water Conservation District Storage Barn will be located on your right. Please follow the traffic plan listed on page one.

**Erie, Pennsylvania:** When traveling from Erie, Pennsylvania: Take I-90 East, merge onto I-86 East and follow signage to Jamestown, New York. Use Exit 12 (Jamestown, New York) to exit 1-86 East. Turn left onto Route 60 (North Main Street Ext.) for approximately 2.5 miles. Take left onto Girts Road and a quick right onto Turner Road. The Chautauqua County Soil & Water Conservation District Storage Barn will be located on your right. Please follow the traffic plan listed on page one.

**Olean, New York:** Take I-86 to Jamestown. Take Exit 12 (Jamestown, New York). Turn **right** onto Route 60 (North Main Street Ext.) for approximately 2.5 miles. Take left onto Girts Road and a quick right onto Turner Road. The Chautauqua County Soil & Water Conservation District Storage Barn will be located on your right. Please follow the traffic plan listed on page one.

**South Dayton, New York:** Take NY-322 West to NY-83 North and head south Rood Road in Arkwright (County Touring Route 77). Follow County Touring Route 77 to NY-60 South to Gerry. It will be necessary to take a right at the traffic light in Gerry, New York to continue to Jamestown, New York on NY-60. Take a **right** onto Girts Road and a quick right onto Turner Road. The Chautauqua County Soil & Water Conservation District Storage Barn will be located on your right. Please follow the traffic plan listed on page one.
